Dear Parents

Namaskar!

“Safety is not just a slogan, its way of life”.

You are aware that Vidyalaya does not provide any transport to ferry the students and you have arranged the transport of your own. Please ensure compliance of the Order No. DE.15(173)/Act-1/Pt/2013/24150-24161 dated 10-06-2014 issued by Directorate of Education to assert the following:-

1. To verify the credentials of the driver, conductor/helper and the vehicle hired by you. It should conform to the provision of Delhi Motor Vehicle Rules, 1993 and have a proper authorized person in it. Moreover, the related information must be intimated to the school duly verified by the Delhi Police within seven days to enable us to forward the same to the Directorate of Education for their record etc.
2. To ensure that all the buses/Vans/RTV's/Cars arranged by the parents have GPS System installed in it and provide the information in this regard to school authorities.
3. To ensure that the driver/vehicle must not be carrying children more than the seating capacity of the vehicle (one and a half times of the seating capacity).
4. To get the PCC of the driver as well as conductor/helper and submit the same in Vidyalaya office latest by 10-10-2019.
5. To ensure that the vehicle hired by you adheres to the latest directions issued by the Transport Authority of India.
6. To ensure that the children are dropped and picked up from Vidyalaya on time.
7. As you are aware that Vidyalaya timings are from 7.45 a.m. to 2.15 p.m. on week days and till 12.15 p.m. on Saturdays. Accordingly students must not arrive Vidyalaya before 7.30 a.m. and depart later than 2.30 p.m. or 12.30 p.m.(on Saturdays). However it has been observed that many students reach and depart Vidyalaya much earlier or later than the scheduled time. It is not safe for the children to stay unattended and several reminders have been given in this regard. Keeping in view the safety and security of children, you are requested to make suitable transport arrangement for timely arrival/departure of your ward.
